

## LAYTIME AND LETTERS OF INDEMNITY

The Chamber of Shipping of British Columbia in partnership with the Institute of Chartered Shipbrokers is pleased to offer a short course to explain the theory, application and resolution of laytime in the dry bulk sector.

Mike Jekyll, President, Tandem Marine

Mike Jekyll entered the shipping industry in 1965 with Bunge and Co. in London before relocating to Vancouver in 1968 to join Gibson Transportation – shipbrokers (now CTL Westrans), broking primarily for Cansulex (later known as Prism Sulphur)

Mike's career then took him to Silver Line in London, trading stainless steel chemical tankers before returning to Vancouver to work with Gibson Transportation and Gulf Shipping/Unimarine until 1980 when Tandem Marine was formed and which became a partner in World Wide Shipping and Chartering.

Tandem, together with Mr. John Olsen subsequently formed Waterfront Chartering – ship brokers. Mike continued broking from 1984 – 2006 operating as Tandem Marine which included a seven year spell with Cormorant Bulk Carriers, operating time chartered vessels in liner services form both coasts to Indian sub continent and Asia.

From 2006-2010 Tandem Marine rejoined Waterfront Chartering and Mike remains President of Tandem Marine in retirement.
